Please Read Carefully

1. The vendor agrees to indemnify the Fulton-Nostrand United Merchants Association, Bed-Stuy Gateway Family Fun Fest or Bedford Stuyvesant Restoration Corporation and it's agents from any costs, loss or damage claimed by a third person as a result of vendor's activities. Vendors are responsible for obtaining any and all necessary permits, licenses and insurance. Vendor must bring in or mail in a copy of permit when returning contract.
2. Registration fee includes one 10'x10' space. The Vendor shall at all times maintain the interior and exterior of the exhibition space and surrounding premises used in connection with such business in the highest degree of cleanliness, orderliness, and sanitation. The Vendor shall construct and repair the exterior and interior of his exhibition space at his own expense.
3. Electricity is the responsibility of the Vendor.
4. Food Vendors are responsible for all permits required by New York City and will not be permitted to set up without proper documentation.
5. Propane tanks must be standard 20 lbs. and certified by the New York City Fire Department. Only two (2) 20-lb. tanks are allowed per food vendor, and they must be in use. Spare or empty tanks are not allowed on the premises.
6. Illegal selling or playing of music will terminate this agreement and all rights of the Vendor hereunder shall cease. Fulton-Nostrand United Merchants Association has the right to shutdown Vendor and have items removed.
7. **Make certified bank check or money order payable to "FNUMA". All payments are non-refundable. (Note see Conditions of Agreement on back.) Please make all checks payable**
8. No construction using wood or heavy materials to build or erect structures is permitted.
9. Breakdown begins at 5pm on July 22, 2006.
10. Applications and fees must be hand delivered or post marked by **July 12, 2006**.
11. Fulton-Nostrand United Merchants Association reserves the right to enter upon the premises at any time for the purpose of examining such premises, inspecting, furnishings and fixtures, operating methods, and ensure compliance with the rules and regulations comprised in this Agreement.
12. The privileges herein granted to Vendor contemplate the exhibition of goods or services at the Fulton-Nostrand United Merchants Association's Bed-Stuy Gateway Family Fun Fest! and the rights herein granted shall not be applied or extended, directly or indirectly, or any other business or enterprise without the express consent in writing of the Fulton-Nostrand United Merchants Association. This agreement contains the entire agreement of the parties and no representations, inducement, promises, or agreements, oral or otherwise, between the parties not embodied herein shall be of any force or effect. No failure of the Fulton-Nostrand United Merchants Association to exercise any power given hereunder, or insist upon strict compliance by the Vendor of any obligation hereunder, and no custom or practice of the parties at variance with the terms hereof shall constitute a waiver of Fulton-Nostrand United Merchants Association's right to demonstrate exact compliance with the terms hereof. The Fulton-Nostrand United Merchants Association and Vendor are not and shall not be considered as joint ventures, partners, or one as agent of the other, and neither shall have the power to bind or obligate the other except as set forth in this agreement.
13. The interest of the Vendor in this agreement is personal and shall not be assigned, transferred, shared or divided, in any manner by the Vendor.
14. Vendor shall conduct his business and maintain such premises in strict compliance with all applicable laws, ordinances, regulations, and other requirements or any federal, state, county, municipal, or other government and will obtain all necessary permits, licenses, or other consents for the operation of his business.
15. If the Vendor shall fail to perform or observe any of the covenants of the Bed-Stuy Gateway Family Fun Fest!, or if any such condition is not remedied to the satisfaction of the Fulton-Nostrand United Merchants Association, it may terminate this agreement and all rights of the Vendor hereunder shall cease.
